INVITATION TO BID

PUBLIC BIDDING

SUPPLY OF LABOR AND MATERIALS FOR THE INSTALLATION OF 12" PRESSURE REGULATING VALVE (PDA 2019-004)

1. The Partido Development Administration, through the PDA Corporate Operating Budget of 2019 intends to apply the sum of **ONE MILLION THREE HUNDRED EIGHTEEN THOUSAND SIX HUNDRED NINETY-FOUR PESOS ONLY (P 1,318,694.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Supply of Labor and Materials for the Installation of 12" Pressure Regulating Valve (PDA 2019-004)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Partido Development Administration now invites bids for the **Supply of Labor and Materials for the Installation of 12" Pressure Regulating Valve**. Completion of the works is required *within 40 days after receipt of Notice to Proceed*. Bidders should have completed a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from Partido Development Administration and inspect the Bidding Documents at the address given below from *August 30, 2019 until September 23, 2019 at 8:00AM – 5:00PM from Monday - Friday*.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of *Five Thousand Pesos Only (Php 5,000.00)*.
6. The Partido Development Administration will hold a Pre-Bid Conference on *September 9, 2019, 2:00 P.M. at PDA Conference Room, PDA Complex, Caraycayon, Tigaon, Camarines Sur* which shall be open to all interested parties.
7. Bids must be duly received by the BAC Secretariat at the address below on or before *September 23, 2019 at 2:00 P.M.* All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on September 23, 2019 at 2:00 P.M. at PDA Conference Room, Partido Development Administration, Caraycayon, Tigaon, Camarines Sur. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The Partido Development Administration reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
9. The Bids and Awards Committee (BAC) shall use a non-discretionary and non-discriminatory measure based on sheer luck or chance, which is "DRAW LOTS", in the event that two or more bidders have been post-qualified and determined as the bidder having the Lowest Calculated Responsive Bid (LCRB) to determine the final LCRB, based on the following procedures:
 - 9.1 In alphabetical order, the bidders shall pick one rolled paper.
 - 9.2 The lucky bidder who would pick the paper with a "CONGRATULATIONS" remark shall be declared as the final bidder having the LCRB and recommended for award of the contract.


